INTRODUCTION

EOC

- A central location for designated personnel to perform emergency management functions
- Coordination of information and resources for efficient and effective response to emergencies

PHEOC

- A PHEOC is an emergency operations center (EOC) that specializes in the command, control, and coordination requirements of responding to emergencies that involve health consequences and public health threats.
- A part of a comprehensive programme of PH emergency management (risk analysis, preparedness, response and recovery).

OBJECTIVES OF PHEOC

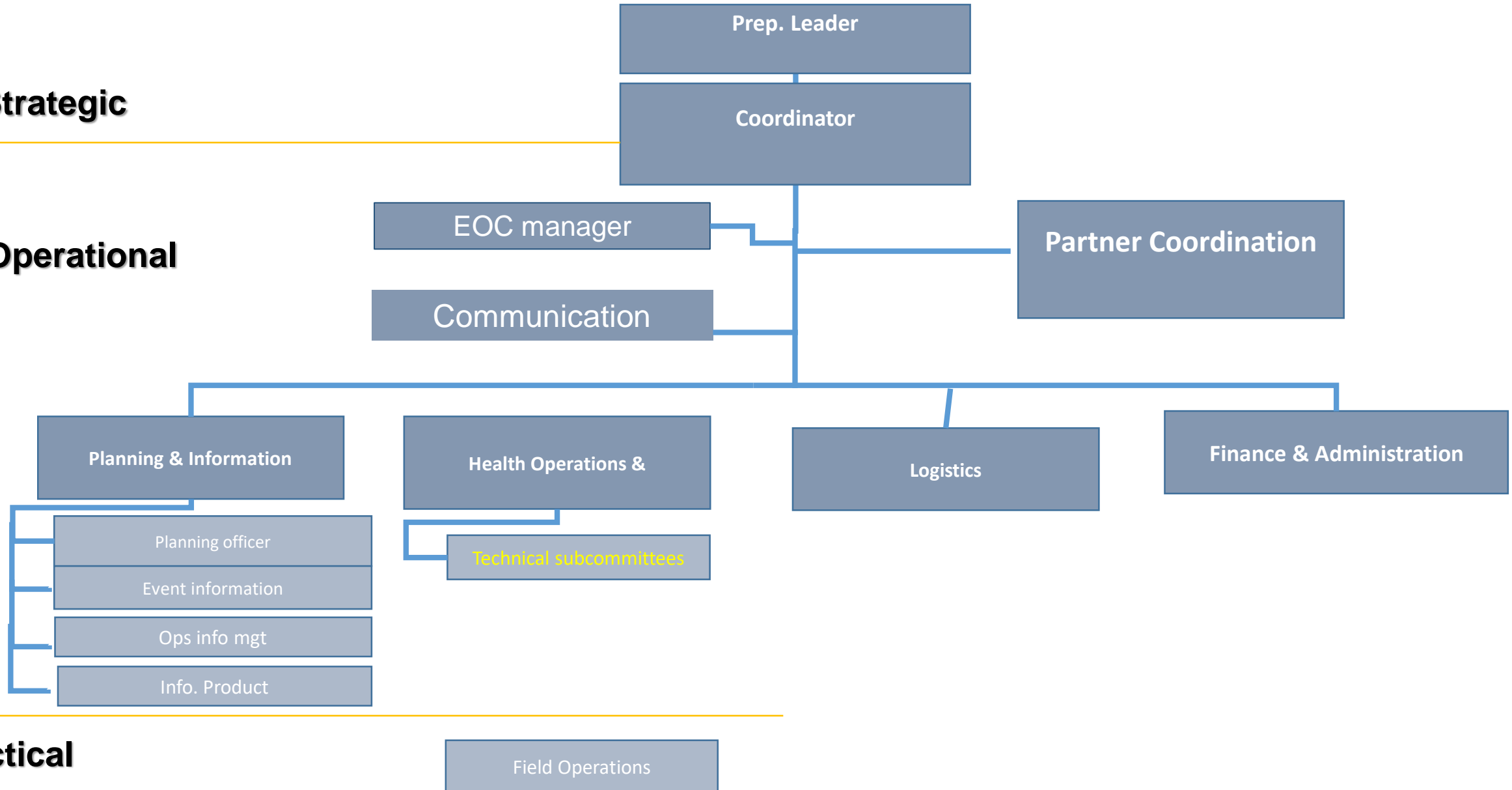
- ◆ Timely, event-specific operational decision-making using the best available information, policy, technical advice and plans
- ◆ Communication and coordination with response partners
- ◆ Collection, collation, analysis and presentation of event data and information to support response planning and documentation
- ◆ Acquisition and deployment of response resources, including surge capacity and services and material support to the EOC itself and to all response personnel
- ◆ Monitoring financial commitments and providing administrative services for the EOC

5. Training Rapid response teams (RRT)

6. Training of health workers on EVD

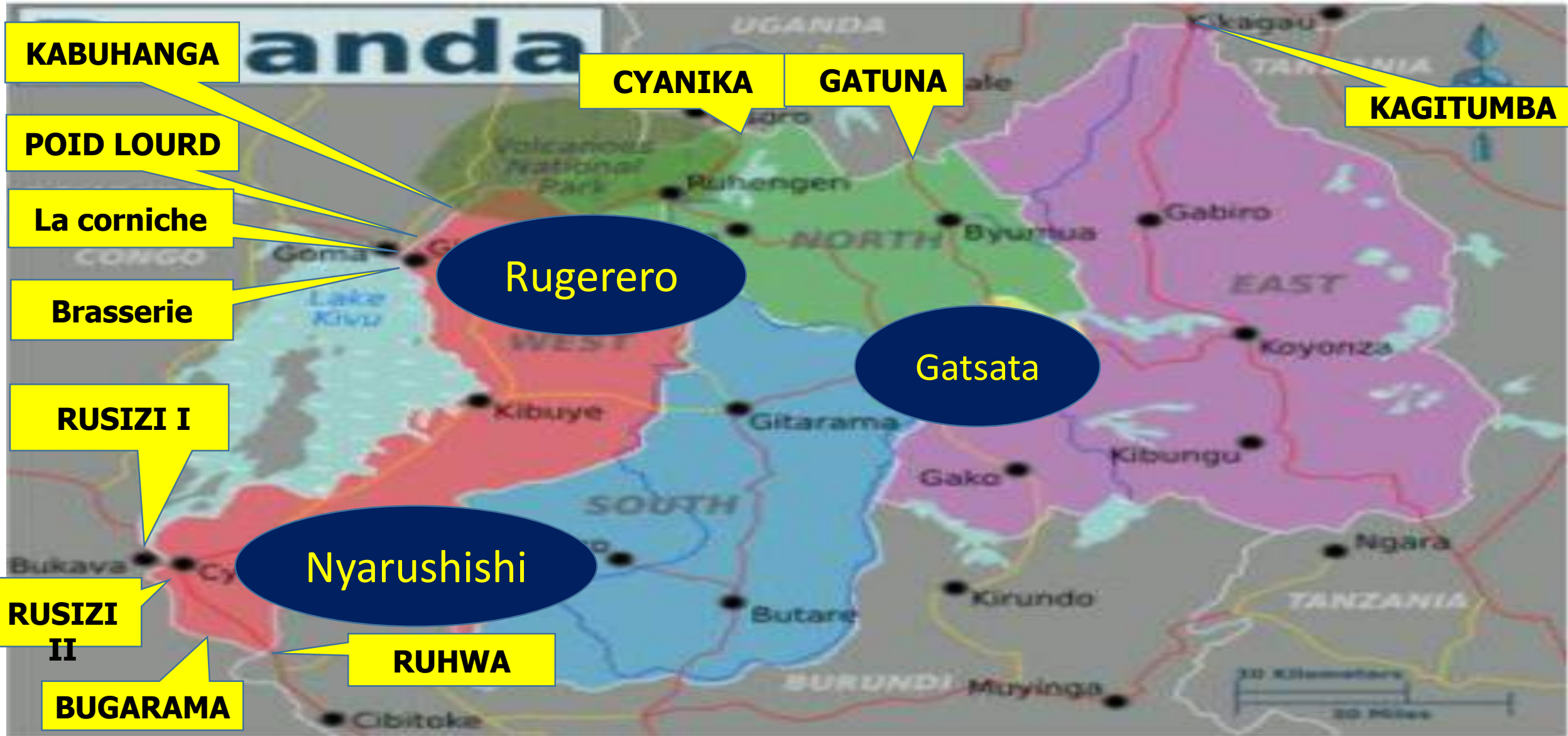
7. Training on contact tracing

- 1.To conduct SIMEX
- 2.To distribute brochures on case definitions to all districts and all health facilities
- 3.To establish a fully functional PHEOC(Equipment &staffing)
- 4.Follow up of fever cases reported
- 5.To ensure the preparedness of ETCs in place
- 6.Data and information management

OBSERVATIONS AND RECOMMENDATION

The Ministry of Health is making effort in scaling up the response to EVD outbreak ,there is a need to continue with the current momentum to scale up and increase the coverage of effective outbreak control interventions

Recommendations

- 2.Intensify risk communication
- 3.Social mobilisation and community engagement
- 4.Effective coordination of all key stakeholders to enhancing preparedness against the spread of EVD outbreak
