Reference is made to the Ministerial Order N° 001/23/10/ TC of 10/10/2023 establishing regulations governing public procurement, in its **article 31 (Paragraph 1)** which says:

Not later than 31st July of every year, each procuring entity must publish an approved annual procurement plan. However, information related to what is provided in Article 30(c) of this Order is not published.

And Paragraph 2 which states that The annual procurement plan includes all tenders to be conducted through electronic and non-electronic procedures.
